UPON hearing the counsel the Court made the following O R D E R

- 1. The matter has come up before us for reporting compliance of the directions issued in the main matter i.e. Writ Petition (Civil) No.538/2023.
- 2. According to the Office Report filed by the Registry, the following High Courts have filed their respective affidavits/status reports:-
 - 1. High Court of Jharkhand
 - 2. High Court of Madhya Pradesh
 - 3. High Court at Calcutta
 - 4. High Court at Patna
 - 5. High Court of Delhi
 - 6. High Court of Kerala
 - 7. High Court of Jammu & Kashmir and Ladakh
 - 8. High Court of Punjab & Haryana
 - 9. High Court at Allahabad
 - 10. High Court of Telangana

11. High Court of Chhattisgarh

- 3. Many High Courts have yet to file their respective affidavits/status reports as regards the compliance.
- 4. We give one last opportunity to the High Courts who have yet to file the status reports. In other words the appropriate compliance report.
- 5. Post it after eight weeks.
- 6. We make it clear that all those High Courts who have not yet filed their respective affidavits/status reports fail to do so within the next eight weeks, then we shall ask the Registrar General of the respective High Courts to personally remain present before us and explain why the Status Reports have not been filed.
